IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

I joined Insigneo on 10/23/2025. Immediately after my hire date, I started working with my clients to move over 100 accounts to our new firm. Over 90% of our clients are based outside of the US, therefore much of the account opening documentation was delivered and processed via email and other digital means. In November 2025 Insigneo determined that certain client documentation we had produced did not meet their standards and requested us to remediate them, which we promptly started doing. Insigneo also confirmed that all of clients had confirmed the paperwork. On 1/28/2026 Insigneo communicated to us that we were being discharged for not following the firm's account opening and ACAT transfer policies



and procedures.
