IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

THE FA FOLLOWED THE CLIENT'S INSTRUCTIONS BY MOVING THE FUNDS FROM THE SUB ACCOUNTS WITH THE HARTFORD AND LINCOLN ANNUITIES AND PLACING THEM IN THE FIXED ACCOUNTS. THE FA AND THE CLIENT HAD BEEN DISCUSSING MOVING THESE FUNDS TO ANOTHER INSURANCE COMPANY TO OPEN A NEW ANNUITY AND ESTABLISHING A NEW DEATH BENEFIT. A CERTAIN AMOUNT OF THE FUNDS WERE TO REMAIN WITH LINCOLN AND HARTFORD TO PRESERVE THE DEATH BENEFITS IN THOSE ANNUITIES. THE CLIENT APPARENTLY CHANGE HIS MIND SEVERAL DAYS AFTER THE EXCHANGES TOOK PLACE AND OPTED NOT TO PURCHASE THE NEW ANNUITY. HE ADVISED THE FA TO LEAVE THINGS AS THEY WERE. THE FA DID NOTHING AND THE FUNDS REMAINED IN THE FIXED ACCOUNTS. THE CLIENT NOTIFIED US AFTER HE RECEIVED HIS OCTOBER, 2011 STATEMENT THAT THE FUNDS INCORRECTLY REMAINED IN THE FIXED ACCOUNTS. THIS INFORMATION WAS ALSO DISCLOSED TO THE CLIENT ON THE AUGUST AND SEPTEMBER STATEMENTS, BUT THE CLIENT DID NOT CORRESPOND WITH US UNTIL THREE MONTHS AFTER THE FUNDS WERE MOVED TO THE FIXED ACCOUNTS. SINCE THE MARKET HAD NOT MOVED SIGNIFICANTLY DURING THE FIRST TWO STATEMENT PERIODS, WE REFUSED TO RETURN THE FUNDS TO THE SUB ACCOUNTS WITH AN AS/OF DATE. WE DID OFFER THE CLIENT \$5,000.00 FOR ANY CONFUSION OR INCONVENIENCE CAUSED BY THIS SITUATION. THE CLIENT DID NOT RETURN THE SETTLEMENT OF CLAIM FORM BY THE REQUESTED DATE, SO WE CLOSED THIS COMPLAINT WITHOUT FURTHER ACTION. .
