What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

I had just started at EFS and made minimal amount of money those first 2 years. I found out about them in 2010 when I moved out and had my mail forwarded to a P.O. box. She had been taking the notices out of the mail and hiding the unpaid taxes from me. I hired an attorney to help work out a solution. The IRS deemed me uncollectable. I did not hear anything about these liens until I received a notice in March 2017 about the Tax liens. They now feel I have the ability to pay is why they have started the collection process again. I have submitted an offer in compromise and am making monthly payments to them until a decision is made on the offer I submitted. I should have an answer by October 2017. All my other tax years are paid up and current.
