What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

I BELIEVE THE CUSTOMER FILED A LAWSUIT SIMPLY BECAUSE HE THOUGHT HE COULD WIN, NOT BECAUSE OF ANY MISREPRESENTATION. I AM NOT A NAMED RESPONDENT IN THIS ACTION AND NO DAMAGES WERE



SOUGHT AGAINST ME PERSONALLY RELATED TO ANY ACTIONS TAKEN BY ME IN CONNECTION WITH THE INVESTMENTS AT ISSUE. THIS SETTLEMENT DOES NOT REFLECT ANY ACKNOWLEDGEMENT OR ADMISSION OF ANY LIABILITY OR MISCONDUCT ON MY PART WHATSOEVER. I WAS NOT ASKED TO PERSONALLY CONTRIBUTE ANY AMOUNT TOWARDS THIS SETTLEMENT OF THIS CASE. UBS RESOLVED THIS ISSUE STRICTLY FOR BUSINESS REASONS TO AVOID POTENTIAL COST AND UNCERTAINTIES OF THE ARBITRATION FORUM. THIS INVESTMENT WAS SUITABLE AND PRESENTED TO THE CLIENT PROPERLY AT THE TIME OF PURCHASE AND ONLY BECAME AN ISSUE DUE TO THE UNFORESEEABLE BANKRUPTCY OF LEHMAN BROTHERS.
