What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement	CLAIMANTS FILED A SUIT AGAINST PNC INVESTMENTS (FORMERLY NATCITY INVESTMENTS) AND MERRILL LYNCH DUE TO A LENGTHY TRANSFER PROCESS AND REAL ESTATE LENDING PRACTICES, NOT FOR MISREPRESENTATION, SUITABILITY OR CHURNING. THE CLAIMANTS' ATTORNEY UTILIZED BOILER-PLATE LANGUAGE IN THE ORIGINAL COMPLAINT LETTER WHICH INCLUDED THE CLAIMS AGAINST THE BROKERS. THE CLAIMANTS INTENTION WAS NEVER TO NAME THE BROKERS IN THE SUIT, AND AS SUCH, THE BROKERS INDEED WERE NOT NAMED, ONLY PNCI AND MERRILL LYNCH. IN FACT, THE CLAIMANTS AND



THE CLAIMANTS' ATTORNEY HAVE SINCE REQUESTED THAT THIS SUIT WOULD BE EXPUNGED (OR REMOVED) FROM THE BROKERS' RECORD. THE BROKERS HAD ZERO FINANCIAL LIABILITY AND THERE WERE ZERO FINDINGS OF MISREPRESENTATION, NON-SUITABILITY OR CHURNING. FURTHERMORE, THE BROKERS HAD NO CONTROL OF THE TRANSFER PROCESS AS THEY ARE MANDATED BY INTERNAL PROCEDURES TO HAVE NO INVOLVEMENT IN TRANSFER PROCESSES. THERE IS A DEDICATED DEPARTMENT FOR ACCOUNT TRANSFERS. LASTLY, A SETTLEMENT WAS REACHED TO AVOID FURTHER LEGAL PURSUIT BY THE CLAIMANTS AGAINST NATIONAL CITY BANK (NOW PNC BANK) FOR ITS REAL ESTATE LENDING PRACTICES. THE CLAIMANTS WERE FORCED TO REPLACE THEIR REAL ESTATE LOANS WITH ANOTHER FINANCIAL INSTITUTION DURING THE 2008 FINANCIAL CRISIS, LEAVING THE CLIENTS VULNERABLE. TODAY, IMMEDIATE FAMILY MEMBERS, INCLUDING THE PARENTS OF THE CLAIMANT, REMAIN GOOD PERSONAL CLIENTS OF THE BROKERS.
