IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations: CLAIMANT [CUSTOMER] CONTENDS THAT VOGEL CONSULTING, RHONA VOGEL, AND [THIRD PARTY] INTENTIONALLY OR NEGLIGENTLY ADVISED [CUSTOMER] TO INVEST \$1,000,000 IN A HEDGE FUND THAT WAS UNSUITABLE FOR HER IN LIGHT OF HER RISK TOLERANCE AND INVESTMENT OBJECTIVES AND THIS ADVICE CAUSED HER TO LOSE A SUBSTANTIAL AMOUNT OF HER INTEREST. [CUSTOMER'S] ACTION ARISES IN CONNECTION WITH THE ILLEGAL AND FRAUDULENT CONDUCT OF WOOD RIVER PARTNERS, ITS MANAGER, [THIRD PARTY], AND ITS PRIME BROKER AMONG OTHERS, WITH RESPECT TO WOOD RIVER'S INVESTMENTS, ITS FAILURE TO MAKE OR FILE CERTAIN DISCLOSURES REQUIRED BY THE SECURITIES EXCHANGE COMMISSION, AND ITS FRAUDULENT REPRESENTATIONS TO INVESTORS. WHITTIER AND WOOD RIVER FRAUDULENTLY INDUCED INVESTORS AND INVESTMENT ADVISORS, INCLUDING VOGEL CONSULTING AND ITS CLIENTS WHO RELIED ON THE INFORMATION THEY PROVIDED, TO INVEST IN CERTAIN HEDGE FUND PRODUCTS. WITH HER CLAIM, [CUSTOMER] SEEKS TO HOLD VOGEL CONSULTING, MS. VOGEL, AND [THIRD PARTY] LIABLE FOR DAMAGE SHE EXPERIENCED THAT WAS DIRECTLY CAUSED BY THE FRAUDULENT CONDUCT OF WOOD RIVER AND OTHERS.
