IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: Money Concepts Capital Corp.

Allegations: The customer wrote to Pershing, LLC, who initially responded on 6/16/2021 and referred this matter to the firm. The customer's chief complaint is the inability to liquidate her investment. She also questions the benefit of the investment, which was made in 2013. Records show customer signed numerous documents acknowledging her understanding of the product, its features, including risks such as illiquidity. The customer's stated objective was Aggressive Income, time-horizon was over 20-years and liquidity did not matter. Firm review indicates the customer made numerous withdrawals since opening the account, depleting all liquid investments in 8-years.
