### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

FA ALSO EXPLAINED THAT THE MARKET VALUE OF ANY ASSET WILL FLUCTUATE UP AND DOWN AND THAT IT IS GENERALLY BEST TO EXPECT TO HOLD FIXED INCOME ASSETS TO MATURITY OR CALL DATES AND EQUITIES FOR THE LONG TERM. FA HAS STATED THIS TOPIC WAS ALSO DISCUSSED DURING THEIR 8/13/08 MEETING WHERE FA AGAIN EMPHASIZED THAT THE ASSET VALUES WOULD FLUCTUATE UP AND DOWN WHILE THE CLIENT OWNED THEM. UPON REVIEW OF THE INVESTMENTS THAT WERE HELD IN THE ACCOUNT, THEY DID NOT APPEAR TO BE OUTSIDE OF THE SCOPE OF THE INVESTMENT OBJECTIVES THAT WERE LISTED ON THE ACCOUNT. WHILE WE UNDERSTAND THE CLIENT'S DISAPPOINTMENT WITH THE PERFORMANCE OF THE PORTFOLIO, IT DOES APPEAR THE PERFORMANCE IS ATTRIBUTED TO MARKET FLUCTUATION WHICH IS A RISK ASSOCIATED WITH INVESTING. BECAUSE THE FUTURE CANNOT BE PREDICTED WITH COMPLETE ACCURACY, WE ENCOURAGE OUR CLIENTS TO PREPARE FOR THE FUTURE BY MAINTAINING DIVERSIFIED PORTFOLIOS.
