### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Regulator Statement**

On 3/23/2018, the Office of Financial Regulation entered a Final Order adopting the Stipulation and Consent Agreement in the matter of David Michael Kovach. Mr. Kovach neither admitted nor denied the findings but consented to the entry of findings by the Office. The Office found that David Michael Kovach failed to send clients itemized invoices; maintain an accurate Form U4; prepare and maintain written supervisory procedures; prepare and maintain written client investment advisory contracts; and comply with the safekeeping requirements of the Florida Securities and Investor Protection Act, Chapter 517, F.S. In addition, David Michael Kovach exercised discretion in two clients' accounts without first obtaining written discretionary authority from the clients. Pursuant to the Final Order, Mr. Kovach agreed to cease and desist from all present and future violations of Chapter 517, F. S. and the administrative rules thereunder; and to pay an administrative fine in the amount of \$10,000.00 jointly and severally with Capital Management Investor Services, Inc.
