IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Employing firm when activities occurred which led to the complaint: ASKAR ADVISORS GROUP, INC. (REGISTERED INVESTMENT ADVISER)

Allegations: ON MAY 23, 2007, CUSTOMER EMAILED ME REGARDING HER ALLEGED LOSS OF \$15,000 TO CLOSE OUT COVERED CALLS SHE SOLD TO OPEN IN FEBRUARY ON ADP IN HER NON-ADVISORY ACCOUNT, I.E., A CUSTOMER-DIRECTED ACCOUNT ON WHICH I EARNED NO COMPENSATION FOR ANY TRANSACTIONS SINCE INCEPTION. ON 3/30/2007, ADP SPUN OFF BR, AND CUSTODIAN FAILED TO NOTIFY CUSTOMER OR ME THAT THE OPEN OPTIONS ADJUSTED TO INCLUDE 25 BR SHARES PER 100 ADP SHARES. SINCE CUSTOMER'S STATED OBJECTIVE WAS TO SELL ADP (EVIDENCED BY HER WRITING CALL CONTRACTS) AND BECAUSE SHE SAID SHE "NEEDED THE MONEY," SHE PLACED ORDER TO SELL BR; I EXECUTED ORDER. CUSTODIAN CALLED 16 DAYS LATER TO NOTIFY THAT BR SALE LEFT CALLS PARTIALLY NAKED, I.E., ACCOUNT WAS "OUT OF COMPLIANCE" BECAUSE ONLY AUTHORIZED FOR COVERED CALLS. CUSTOMER CHOSE TO BUY BACK THE CALLS TO CLOSE THE OPTIONS AT A LOSS. ON 6/11/2007, MET WITH CUSTOMER TO EXPLAIN THAT LOSS ON OPTIONS WAS SIGNIFICANTLY OFFSET BY UNDERLYING STOCK APPRECIATION, AND THAT BY CLOSING OPTIONS, SHE BOUGHT BACK THAT "IN THE MONEY" VALUE. CUSTOMER AGREED THAT THE ECONOMIC IMPACT OF THESE OPTION TRANSACTIONS COULD NOT BE VIEWED IN ISOLATION FROM THE UNDERLYING STOCK APPRECIATION SHE BOUGHT BACK. CUSTOMER AGREED TO ACCEPT \$3,000 FOR MISUNDERSTANDING, OF WHICH CUSTODIAN PAID \$2,000 FOR FAILING TO PREVENT/TIMELY NOTIFY. RIA PAID \$200 AND I PAID \$800.
