IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

AT THE TIME OF PURCHASE CLIENT EXECUTED THE TRANSFER OF ASSETS: ANNUITY TO VARIABLE ANNUITY DOCUMENT IN WHICH CLIENT ACKNOWLEDGED SHE DISCUSSED COMMISSIONS (BREAKPOINTS WERE APPLIED TO PURCHASE), FEES, DEATH BENEFIT, LIVING BENEFIT, RISK, PROSPECTUS, CONTRACT, RIGHT TO EXAMINE, DOLLAR COST AVERAGING AND ANNUITIZATION. IN ADDITION CLIENT EXECUTED ALL 1035 EXCHANGE PAPERWORK. CLIENT WAS PROVIDED WITH A PROSPECTUS/CONTRACT ON THE LINCOLN ANNUITY AS VERIFIED BY CLIENT'S SIGNATURE DATED 8/23/08. THE PROSPECTUS AND CONTRACT PROVIDE CLIENT WITH ALL DETAILS ASSOCIATED WITH ANNUITY CONTRACT AND ANY RIDERS ELECTED ON THE CONTRACT. IT APPEARS THROUGH DISCUSSIONS WITH FA AS WELL AS THROUGH THE CONTRACT, CLIENT WAS MADE AWARE OF THE RIGHT TO CANCEL WHICH SHE ELECTED NOT TO EXERCISE. BASED ON OUR REVIEW, IT IS OUR OPINION CLIENT WAS FULLY AWARE OF ALL DETAILS ASSOCIATED WITH THE ANNUITY 1035 EXCHANGE. FURTHER, IT APPEARS CLIENT WAS IN RECEIPT OF THE ANNUITY PROSPECTUS AND CONTRACT WHICH PROVIDED CLIENT WITH ALL DETAILS ASSOCIATED WITH THE LINCOLN ANNUITY.
