**Allegations:** CLIENT ALLEGES THAT REPRESENTATIVE MISREPRESENTED THE SALE OF CIT GROUP BOND. CLIENT FURNISHED PROPOSAL FROM FA WHICH DENOTED THE RECOMMENDATION OF A PRUDENTIAL FINANCIAL BOND. FA DISPUTES THE ALLEGATION CLAIMING THAT HE CALLED THE CLIENT TO DISCUSS THE CIT GROUP PURCHASE AS IT OFFERED A BETTER YIELD. PURCHASE OCCURED IN AUGUST 2007, CLIENT COMPLAINT WAS RECIEVED IN APRIL 2008 WHEN CLIENT NOTICED A SHARP DROP IN THE PRICE OF THE BOND IN THEIR ACCOUNT. INVESTIGATION WAS UNDERTAKEN INTO FA CONDUCT. CLIENT COMPLIANT ALLEGATION CHANGED 3 TIMES WHILE BEING INVESTIGATED. ULTIMATELY THE CLIENT REQUESTED THE ACCOUNT BE LIQUIDATED AND THAT WAYNE HUMMER MAKE UP THE LOST AMOUNT. FIRM REFUSED TO MAKE THE CLIENT WHOLE AND CLIENT HAS SINCE PURSUED ARBITRATION.
