IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

ACCORDING TO FA, HE REVIEWED CLIENT'S PORTFOLIO IN DECEMBER 2007 AND IT WAS DURING THIS MEETING THAT CLIENT INFORMED HIM HE WOULD BE DEPOSITING \$40,000.00 INTO THE ABOVE-REFERENCED ACCOUNT. FA HAS STATED CLIENT DEPOSITED THE FUNDS ON JANUARY 4, 2008 AND HE CONTACTED THE CLIENT ON JANUARY 7TH TO REVIEW HIS INVESTMENT RECOMMENDATION. FA INDICATED HE HAS NO RECOLLECTION OF DISCUSSING AN INVESTMENT THAT PAID A 5% FIXED RATE THAT WAS GUARANTEED; HOWEVER, HE DID RECOMMEND INVESTING THE FUNDS INTO THE BOND FUND OF AMERICA AND THE CLIENT CONSENTED. IT WOULD APPEAR CLIENT WAS AWARE THAT THIS WAS A MUTUAL FUND, AS HE HAD BEEN PURCHASING MUTUAL FUNDS SINCE 2005. THE PURCHASE OF THE MUTUAL FUND WOULD HAVE BEEN DOCUMENTED BY A TRADE CONFIRMATION, AS WELL AS, CUSTOMER ACCOUNT STATEMENTS. FA HAS STATED HE HAS SPOKEN WITH THE CLIENT ON VARIOUS OCCASIONS DURING 2008 AND IT WAS NOT UNTIL DECEMBER 2008 THAT HE INDICATED CONCERN RELATING TO THE MUTUAL FUND PURCHASED ELEVEN MONTHS PRIOR. WHILE WE CERTAINLY UNDERSTAND THE CLIENT'S DISAPPOINTMENT IN THE PERFORMANCE OF THIS INVESTMENT, WE HAVE BEEN EXPERIENCING TUMULTUOUS MARKET CONDITIONS, WHICH HAVE HAD A SIGNIFICANT IMPACT ON ACCOUNT VALUATIONS. BASED ON OUR REVIEW, IT DOES NOT APPEAR THE BOND FUND OF AMERICA (INCOME FUND) WAS OUTSIDE THE SCOPE OF THE STATED INVESTMENT OBJECTIVES OF THIS ACCOUNT. AS A RESULT OF OUR ANALYSIS, WE WILL NOT BE MAKING ANY ADJUSTMENT TO THE CLIENT'S ACCOUNT RELATING TO THE LOSSES (REALIZED OR UNREALIZED) WITH THE BOND FUND OF AMERICA MUTUAL FUND.
