### What is included in a IAPD report?

**Regulator Statement**

On February 15, 2017, the Office of Financial Regulation entered a Final Order against Scott Jackson adopting the Stipulation and Consent Agreement in the matter of Scott Jackson. Scott Jackson neither admits nor denies the findings by the Office. The Office found that Scott Jackson failed to comply with the custody and safekeeping requirements of the Florida Securities and Investor Protection Act, Chapter 517, F.S., send clients itemized invoices, prepare, maintain accurate investment advisory agreements, deducted fees from client accounts which differed from the contracted advisory fees, and maintain an accurate form U-4. A \$6,000 administrative fine was paid.
