The customer held another non-traded investment at the time of this purchase and was aware of the lack of liquidity and risk of loss of principal. The risks were disclosed and the investment was suitable at the time of purchase. Though I was not personally named as a respondent in the arbitration, I assisted LPL to defend against these false allegations. I understand that LPL elected to settle the case because of the ongoing legal costs and uncertainties of litigation. I continue to deny any allegations of wrongdoing with respect to these investment recommendations or the handling of the customer's account.
