## IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

AT THE TIME OF THE PURCHASE, THE CLIENT HAD ONLY \$4,281 AVAILABLE TO COVER THE PURCHASE OF \$17,644.45. THE TRADE SETTLED ON MARCH 18, 2009. ON MARCH 20, 2009, THE TRADE WAS TWO DAYS OVERDUE; AN EXTENSION WAS NOT ALLOWED ACCORDING TO REGULATION T. THIS MEANS PAYMENT WAS DUE ON CLOSE OF BUSINESS ON MARCH 20, 2009 TO AVOID A QUANTITY REDUCTION. TYPICALLY, THE CLIENT IS CONTACTED GIVEN HIM THE OPPORTUNITY TO COVER THE TRADE. IT IS OUR UNDERSTANDING PAYMENT WAS COMING FROM AN OUTSIDE SOURCE, A DISTRIBUTION FROM THE PROTECTIVE ANNUITY; HOWEVER, THE PAYMENT WAS NOT RECEIVED BY MARCH 20, 2009. IT IS OUR UNDERSTANDING THE CLIENT WAS NOT CONTACTED ABOUT THE PROTECTIVE PAYMENT NOT BEING RECEIVED IN TIME TO COVER THE AMOUNT DUE. AS SUCH, THE TRADE WAS REDUCED FROM 10,000 SHARES TO 2,411 SHARES. IN LIGHT OF THESE CIRCUMSTANCES, WE ARE OFFERING THE CLIENT THE ABILITY TO PURCHASE AN ADDITIONAL 7,589 SHARES ON MARCH 13, 2009; THE PRICE PER SHARE WAS \$1.73. IN ORDER TO ENTER THE TRADE, THE CLIENT WILL NEED TO DEPOSIT THE \$13,363.45 TO COVER THE PURCHASE. THE FUNDS TO COVER THE PURCHASE WILL NEED TO BE DEPOSITED BEFORE THE TRADE WILL PLACED. IF THE CLIENT ACCEPTS THE OFFER, HE WILL NEED TO DEPOSIT THE FUNDS AND SIGN THE ATTACHED SETTLEMENT OF CLAIM WITHIN 10 BUSINESS DAYS FROM THE DATE OF THIS LETTER. THE CLIENT ACCEPTED THE OFFER.
