What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement Following termination, Mr. Block was told that the termination was due to two items that are in relation to "backlinking." First, a local website on which Mr. Block posted approved marketing content was being promoted on multiple social media channels. The firm took issue with Mr. Block posting the website URL on his Instagram site. Second, Mr. Block posted a link to his LinkedIn page on his Twitter account. Mr. Block was ready to voluntarily resign from his position, but was denied that ability and terminated for cause by the firm.
