**Broker Statement** Customer's allegations are clearly false and erroneous because the recommendations were aligned with customer's investment objectives, the alternative investments represented less than 10% of the customer's liquid net worth, and they were positioned within a well-diversified portfolio of other investments. Customer indicated that she understood the risks and attributes of the investments, as is further confirmed by her signature on documents containing all material disclosures. Ultimately, the dispute was settled privately, for a nuisance amount, to avoid any further costs and business disruption associated with litigation.
