Where did this information come from?

Firm Statement FP vehemently denies the complaint allegations as well as denies any wrongdoing

brought forth by his ex-wife (account owner). The 529 account owner (ex-wife) verbally agreed on multiple occasions over the span of 2 years to allow FP to withdraw funds from the 529 plan account to cover the education costs of equally shared children. It is important to note that FP is the contingent owner, father of the 529 plan account beneficiary and all contributions made to the 529 plan account since inception have been contributed to by FP from his earned income and the 529 plan account beneficiary's grandparents. No contributions have ever been made by the account owner. Despite these false and egregious allegations, all withdrawn 529 plan account funds have been redeposited back into the 529

plan account in full.
