What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I deny the client's allegations in full. The client was presented several investment alternatives, including but not limited to a fee-based, 3rd party asset management alternative and a variable annuity. The client decided the variable annuity was a better fit based upon the potential for adding guarantees post-issue and the wide array of additional investment subaccounts. Further, the client chose the specific share-class based upon our comprehensive, required legal disclosure of all fees and charges including applicable surrender charges. After holding the product for almost 3 years, while on a recorded phone call, the client stated, "like I said to you guys before, so this 'beef' (complaint) is not with you guys. This is directly with Transamerica". The client complaint was entered a full seven years after the initial transaction was placed. The client did not lose money on the investment.
