IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THE ORIGINAL SALE WAS MADE WITH THE CLIENT TALKING DIRECTLY WITH THE ARS DESK AT THE FIRM. IN 2005, THE FIRM



REORGANIZED MAKING A DIFFERENT FINANCIAL ADVISOR THE DESIGNATED BROKER FOR OUR OFFICE. THE ARS MATURED WEEKLY AND THEN WERE RENEWED EACH WEEK FROM THE ORIGINAL PURCHASE DATE OF JUNE 2004 THROUGH THE MID FEBRUARY 2008. BECAUSE OTHER FIRMS WERE REPURCHASING ARS AND MY FIRM DID NOT, THE CLIENT SENT A WRITTEN COMPLAINT TO THE FIRM WHILE LETTING ME KNOW IN ADVANCE THAT THEY WERE SENDING THIS LETTER DIRECTLY TO THE FIRM BUT THAT I WAS NOT NAMED IN THE CUSTOMER COMPLAINT. CORRESPONDENCE FROM MY FORMER FIRM TO ME STATES, " BANC OF AMERICA INVESTMENT SERVICES, INC (BAI) ENTERED INTO SETTLEMENT AGREEMENTS WITH THE SEC AND VARIOUS STATE REGULATORS WHEREBY BAI WAS REQUIRED TO REPURCHASE AUCTION RATE SECURITIES (ARS) FROM CLIENTS WHO HAD BEEN SOLD THESE SECURITIES. SUBSEQUENTLY, FINRA ISSUED A RULING THAT THESE ARS REPURCHASES MUST BE CONSIDERED AS CUSTOMER COMPLAINT SETTLEMENTS THAT MUST BE REPORTED ON FORMS U-4 OR U-5 AS APPROPRIATE".
