IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

CLIENT CLAIMS THE FA HAD HIM SIGN THE ANNUITY DELIVERY RECEIPT IN A RUSH BEFORE HE HAD TIME TO CHECK IT OVER. CLIENT ALSO CLAIMS THE ANNUITY DOCUMENTS WERE SENT TO THE FA'S HOME ADDRESS. CLIENT CLAIMS HE MET WITH FA ABOUT TAKING A WITHDRAWAL FROM HIS ANNUITY AND WAS REFERRED TO A FRIEND OF THE FA'S TO REFINANCE HIS HOME AND OBTAIN A HOME EQUITY LOAN. FA MET WITH CLIENT JULY 2008 ON CONCERNS W/ SPENDING SAVINGS & ENSURING CLIENT WOULD NOT RUN OUT OF FUNDS IN 3-4 YRS. FA SUGGESTED IMMEDIATE ANNUITY WITH GENWORTH & REFERRED CLIENT TO LOOK AT OPTION OF REFINANCING HOME TO PAYOFF DEBT & REDUCE OVERALL MONTHLY PMTS. FA REVIEWED DETAILS OF ANNUITY PROVIDING A MONTHLY INCOME OF \$957.55 FOR 11 YRS. CLIENT HAD INDICATED THEY HAD OTHER FUNDS FOR IMMEDIATE NEEDS & WAS IMPORTANT TO INVEST FUNDS IN MANNER WHICH WOULD NOT ALLOW PRINCIPAL TO BE EASILY ACCESSED. FA STATED CLIENT AUTHORIZED PURCHASE OF ANNUITY. ANNUITY APP WAS SIGNED ON 7/21/08. FA INDICATED DELIVERED CONTRACT & PROSPECTUS TO CLIENT AT HIS HOME & HE SIGNED DELIVERY RECEIPT 8/20/08. HE FURTHER INDICATED CONTRACT HE DELIVERED WAS FOR SAME PRODUCT HE HAD SPOKEN WITH CLIENT ABOUT. THE MORTGAGE BROKER IS A BUSINESS ASSOCIATE FA KNEW THROUGH A REFERRAL GROUP. CLIENTS MET WITH MORTGAGE BROKER & IT WAS DETERMINED TO OBTAIN THE 2ND MORTGAGE TO PAYOFF DEBT.



FA STATED REFINANCE WAS ON TRACK; HOWEVER, CLIENT ELECTED NOT TO PROCEED. A FEW MONTHS LATER CLIENT CONTACTED MORTGAGE BROKER TO PROCEED; HOWEVER, OPTION WAS NO LONGER AVAILABLE TO CLIENT. FA WAS NOT AWARE OF PROBLEM IN GENERAL WITH THIS INDIVIDUAL NOT RETURNING CALLS. IT APPEARS IMMEDIATE ANNUITY WAS PURCHASED BASED ON DISCUSSIONS WITH FA & WITH CLIENTS AUTHORIZATION. ADDITIONALLY, CLIENT WAS IN RECEIPT OF ANNUITY CONTRACT & IT DOES NOT APPEAR CONCERNS WITH REGARD TO CONTRACT WERE BROUGHT TO ATTENTION OF FA NOR WAS A REQUEST TO CANCEL THE CONTRACT MADE UNDER RIGHT TO CANCEL PROVISION. THE REFINANCE ON CLIENT'S HOME WAS INITIALLY AVAILABLE; HOWEVER CLIENT ELECTED NOT TO PROCEED & WHEN CLIENT CONTACTED THE MORTGAGE BROKER A FEW MONTHS LATER OPTION WAS NO LONGER AVAILABLE. CLAIM DENIED.
