**Allegations:** CLAIMANT CLIENT ALLEGES THAT HER JONES FA FAILED TO PROPERLY INFORM HER OF THE TIME FRAME ASSOCIATED WITH TRANSFERRING HER MUTUAL FUNDS HELD AT JONES INTO HER NEW ADVISORY SOLUTIONS ACCOUNTS, ALSO WITH JONES. CLAIMANT ALLEGES THAT THAT ACTUAL TIME FRAME FOR TRANSFERRING HER MUTUAL FUNDS TO THE NEW ADVISORY SOLUTIONS ACCOUNT TOOK LONGER THAN WHAT HER FA REPRESENTED. AS A RESULT, CLAIMANT ALLEGES THAT THE MARKET TIMING DIFFERENCE RESULTED IN A LOSS OF \$19,000. (DAMAGES SOUGHT: \$25,893.33 FOR UNAUTHORIZED AND INAPPROPRIATE TRADE PRACTICES AND BREACH OF FIDUCIARY DUTY, PLUST COSTS).
