IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

METLIFE SINGLE PREMIUM IMMEDIATE ANNUITY WAS ISSUED ON 11/23/09. THE IMMEDIATE ANNUITY WAS DISCUSSED AS MEANS TO PROVIDE REGULAR MONTHLY INCOME & TO ATTEMPT TO PROVIDE THE HIGHEST INCOME PAYOUT AVAILABLE. FA STATED HE SPOKE WITH BOTH TRUSTEES REGARDING THE IMMEDIATE ANNUITY & PAYOUT OPTIONS. APPLICATION WAS EXECUTED BY TRUSTEES. FA STATED TRUSTEES WERE NOT CONCERNED WITH FUNDS PASSING TO BENEFICIARY; THEREFORE, LIFE ONLY PAYOUT OPTION WAS SELECTED AS MEANS TO OBTAIN HIGHEST MONTHLY INCOME PAYMENT DURING LIFETIME. TRUSTEES EXECUTED THE LIFE ONLY ACKNOWLEDGEMENT FORM WHICH SPECIFICALLY STATES THEY UNDERSTAND THAT UPON DEATH OF LAST SURVIVING ANNUITANT ON OR AFTER INITIAL PAYMENT DATE, NO FURTHER PAYMENTS WILL BE MADE UNDER THE CONTRACT. FA INDICATED HE WAS NOT MADE AWARE OF CONCERNS WITH MOTHER'S HEALTH UNTIL AFTER CONTRACT WAS PURCHASED AND SHE WAS NOT PLACED IN CARE FACILITY UNTIL AFTER THAT TIME. FA STATED HE VISITED ANNUITANT AT TRUSTEE'S REQUEST & TRUSTEE WAS PRESENT AT MEETING. HE INDICATED TRUSTEE APPEARED TO HAVE FULL UNDERSTANDING OF PAYOUT OPTION & ASSISTED FA WITH REVIEWING TERMS OF CONTRACT WITH ANNUITANT. FA STATED, AFTER MEETING, TRUSTEES AGAIN ACKNOWLEDGED THEIR UNDERSTANDING OF TERMS OF CONTRACT. IMMEDIATE ANNUITY WAS PRESENTED AS OPTION BASED ON DISCUSSIONS WITH FA AS WELL AS INFORMATION AVAILABLE TO HIM AT THAT TIME. CONTRACT WAS DISCUSSED IN DETAIL WITH TRUSTEES & BOTH SIGNED CONTRACT, ACKNOWLEDGMENTS AND DELIVERY RECEIPT ASSOCIATED WITH CONTRACT. WHILE THE CONTRACT DOES CONTAIN A RIGHT TO CANCEL OPTION, IT APPEARS NO OFFICIAL REQUEST FOR CONTRACT TO BE CANCELLED WAS MADE UNTIL AFTER FIRST SCHEDULED PAYOUT & OUTSIDE TERMS OF RIGHT TO CANCEL PROVISION. EDWARD JONES ATTEMPTED TO OBTAIN EXCEPTION FROM METLIFE TO ALLOW CONTRACT TO BE SURRENDERED; HOWEVER, METLIFE DECLINED OUR REQUEST. CLAIM DENIED.
