STACHOWIAK DENIES ANY WRONG DOING WHILE WITH CCO INVESTMENTS MR. STACHOWIAK HAS SERVICED THE ACCOUNT FOR ONLY A FEW MONTHS. AFTER HE HAS LEFT THE ACCOUNT HAS BEEN RE-ASSIGNED TO ANOTHER REPRESENTATIVE. DURING MR. STACHOWIAK'S INVOLVEMENT THERE WERE NO LOSSES ON THE INVESTMENT.
