IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: AN ASSET TRANSFER WAS RECEIVED INTO THE CLIENT'S VANGUARD PRIME MONEY MARKET FUND ON MAY 21, 2014. THE CLIENT SENT AN EMAIL REQUESTING THE ASSETS BE EXCHANGED INTO A VANGUARD TARGET RETIREMENT FUND. THE CLIENT'S REQUEST WAS NOT IN GOOD ORDER AS VANGUARD DOES NOT ACCEPT TRADES VIA EMAIL. HOWEVER, THE CUSTOMER ALLEGES MR. KOLB CONFIRMED THAT THE ASSETS THE CLIENT DECIDED TO MOVE TO VANGUARD HAVE ARRIVED AND BEEN INVESTED ACCORDING TO YOUR INSTRUCTIONS. THE PURCHASE OF THE VANGUARD RETIREMENT FUND DID NOT OCCUR UNTIL SEPTEMBER 12, 2014, WHICH RESULTED IN FEWER SHARES HAD THE ASSETS BEEN INVESTED AROUND THE TIME THE ASSETS WERE FIRST RECEIVED.
