THAT I HAD VIOLATED A STATE INVESTMENT LAW BY ADVERTISING THE PROPERTY IN THE PAPER WITHOUT IT BEING REGISTERED WITH THE STATE. HE THEN INFORMED ME THAT I COULD EITHER REGISTER THE PROPERTY APPROPRIATELY OR QUIT ADVERTISING THE PROPERTY IN THE NEWSPAPER AND SIGN A CEASE AND DESIST AGREEMENT. I AGREED TO QUIT ADVERTISING THE PROPERTY AND SIGN THE CEASE AND DESIST AGREEMENT.

NO ATTORNEYS, COURTS OR FINES WERE INVOLVED AND I NEVER AGAIN HEARD ANYTHING FROM THE STATE OF KANSAS.
