What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: In a telephone conversation on March 1, 2024, Claimant alleged that Prosper Financial Advisers ("Prosper") and its agents/owners agreed in August 2023 to allocate cash in certain of Claimant's accounts to a money market fund rather than the custodian's sweep account. Had the cash been allocated in such a manner, Claimant would have earned a higher return.

Broker Statement

Claimant alleged that Prosper Financial Advisers ("Prosper") and its agents/owners agreed to allocate cash in certain of Claimant's accounts to a money market fund rather than custodian's sweep account. Had the cash been allocated in such manner, Claimant would have earned a higher return. Client received multiple documents, at different times during the engagement, and had access to client's portal, at all times during the engagement, reflecting that cash had not been allocated to money market funds but rather had been allocated to custodian's sweep account. Claimant never raised with Prosper any discrepancy with how the cash was being allocated. Claimant raised the discrepancy with Waverly Advisors, LLC, which had purchased the investment advisory business of Prosper in the interim, many months after the cash was allocated by Prosper to the sweep account. Waverly Advisors, LLC and Claimant agreed to settle the interest rate differential for a lump sum payment of \$17,025.55. The settlement was subject to the parties' (and predecessors) express rejection of any liability or wrongdoing.
