What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

COULD SPEAK TO THEM ABOUT THEIR ANNUITY PRODUCT CONCERNS; THROUGH 4/17/08 NO SUCH CONTACT OCCURRED. ON 5/7/08 AVIVA OFFERED [CUSTOMER] A COMPROMISE BASED ON HER SUGGESTION THAT THE INS. CONTRACT FACE AMOUNT BE REDUCED TO A POINT WHERE NO FURTHER PREMIUMS WOULD BE REQUIRED. [CUSTOMER] WAS ASKED TO RESPOND TO THE OFFER NO LATER THAN 5/27/08. I FEEL THAT THIS WILL BE ACCEPTABLE TO [CUSTOMER] AS IT WAS HER SUGGESTION AND DO NOT ANTICIPATE ANY FURTHER COMPLAINT OR ACTION BEYOND IT.
