What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement ALLEGED COMPENSATORY DAMAGE AMOUNT ESTIMATED TO BE MORE THAN \$5,000.00. THE CLIENT WAS AN INHERITED ACCOUNT FROM AN ADVISOR WHO LEFT THE FIRM. I WAS INVOLVED WITH THE CLIENT FOR FOUR MONTHS BEFORE RECEIVING THE COMPLAINT ON 2/29/08. COINCIDENTLY, IN THE FOUR MONTH PERIOD THAT I WAS INVOLVED WITH



THE CLIENT, THE S&P 500 DROPPED -14%. THE CLIENTS PREVIOUS PORTFOLIO WAS INVESTED IN OVER 90% EQUITY. THE RE-ALLOCATED PORTFOLIO HAD LESS THEN 50% EQUITY. THE CLIENT SIGNED OFF (VERBALLY AND IN WRITING) ON ALL TRANSACTIONS. THE TOTAL PERCENTAGE COST TO LIQUIDATE THE PORTFOLIO WAS 0.24% OR \$2,870. TWO WEEKS AFTER THE CLIENT AUTHORIZED THE CHANGE IN THE ORIGINAL PORTFOLIO, THE CLIENT BROUGHT IN AN UNSOLICITED ADDITIONAL AMOUNT OF \$550,000. THE CLIENT GAVE VERBAL AND WRITTEN INSTRUCTIONS TO INVEST THE FUNDS IN THE EXACT SAME ALLOCATION AND INVESTMENT STRUCTURE AS THE ORIGINAL PORTFOLIO. THESE ALLEGATIONS ARE FALSE AND HAVE BEEN MADE BECAUSE THE MARKET TURNED DOWN SEVERELY OVER A FOUR MONTH PERIOD. THE CLIENT LEAVES OUT OF HER WRITTEN COMPLAINT THAT THE ORIGINAL PORTFOLIO (INVESTED IN MORE THEN 90% EQUITIES) DROPPED MORE IN VALUE THEN THE NEW ALLOCATED PORTFOLIO (INVESTED IN LESS THEN 50% EQUITIES) NET OF ALL FEES AND/OR COMMISSIONS. AFTER INVESTIGATION, IT WAS DETERMINED THAT THE FA ACTED PROPERLY AND NO SALES PRACTICE VIOLATIONS OCCURRED. COMPLAINT DENIED.
