### **What is included in a IAPD report?**

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### **Where did this information come from?**

**Allegations:** Without admitting or denying the findings, Howell consented to the sanction and to the entry of findings that he falsified documents by creating and sending to his customer weekly Stock Tracking Reports that purported to reflect the value of the customer's portfolio, but actually misstated the value of the accounts. In an effort to conceal this misconduct, Howell also altered three account statements from his member firm to match the false information in the Stock Tracking Reports. The findings stated that Howell caused his firm to keep inaccurate books and records by sending certain Stock Tracking Reports to the customer using his personal e-mail address, which the Firm prohibited. As a result, the Firm did not preserve this customer correspondence as required. The findings also stated Howell refused to respond to FINRA's request for testimony.
