BASED ON WELLS FARGO PROCEDURES, AND MY TRAINING IN 2013, WHEN A VALUED CUSTOMER DEMANDS FALLS OUTSIDE OUR REGULAR GUIDELINES, A MANAGER REVIEW THE SITUATION AMD



MAKE THE ULTIMATE FINAL DECISION TO HONOR THE REQUEST OR REFUSE IT. NOT TO LOSE A VALUED CUSTOMER IN THIS CASE, THE CUSTOMER WANTED TO OPEN A NEW ACCOUNT WITH HER DAUGHTER AND SON'S NAME, AS SHE ALREADY HAD TWO OTHER EXISTING BANK ACCOUNTS WITH ALL THREE NAMES, HOWEVER THIS TIME, HER SON WAS NOT PRESENT. WHILE I REFUSED TO OPEN SUCH A BANK ACCOUNT, I HAD TO FOLLOW WELLS FARGO'S PROCEDURE, AND GET MY MANAGER TO REVIEW AND MAKE A FINAL DECISION TO ACCOMMODATE OUR CUSTOMER OR NOT. AFTER MY MANAGER REVIEWED THE CUSTOMER RELATIONSHIP, AND OTHER TWO EXISTING JOINT ACCOUNTANTS WITH ALL THREE NAMES, MY MANAGER ASKED ME TO GO AHEAD AND OPEN THE THIRD ACCOUNT, SIMILAR WITH ALL THREE NAMES. I FOLLOWED DIRECTION OF MY MANAGER AS I WAS INSTRUCTED AND TRAINED TO DO, AND WAS IN LINE WITH WELLS FARGO POLICIES AND PROCEDURE AT THE TIME IN 2013.
