What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Regulator Statement On July 5, 2023, the Office of Financial Regulation (Office) entered a Final Order in the matter of Charles Kasner Investment Advisor LLC (CKIA) and Charles Ian Kasner (Kasner). The Office found that CKIA and Kasner violated Section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. CKIA and Kasner paid an administrative fine in the amount of \$1,000. The Office agreed to approve the applications for CKIA as an investment adviser and Kasner as an associated person (RA) with CKIA effective July 5, 2023.

Broker Statement
