**Allegations:** CLIENTS ALLEGE THAT THE SALE OF VARIOUS 2004 VARIABLE LIFE INSURANCE POLICIES WERE NOT SUITABLE INVESTMENTS. CLIENTS ALLEGE THAT THE INVESTMENTS UNDERLYING THE PRODUCTS HAD A SIGNIFICANT LEVEL OF RISK AND WERE NOT SUITABLE WHEN CONSIDERING THE NET WORTH AND INDIVIDUAL INCOME LEVELS. CLIENTS ARE REQUESTING THAT THE FIRM MAKE AN OFFER OF RESCISSION TO PURCHASE BOTH LIFE INSURANCE POLICIES AT COST THUS WAIVING THE 6% SALES CHARGE & OTHER CHARGES NET OF THE CAPITAL GAINS, AS WELL AS THE SURRENDER PENALTIES OF \$11,567. IN ADDITION, THEY ARE REQUESTING THE RETURN OF \$3,000 PAID IN TAX PENALTIES, \$7,500 FOR INCOME TAXES PAID AS A RESULT OF AN INAPPROPRIATE CONVERSION AND \$2,000 FOR ATTORNEY FEES.
