Allegations: ATTORNEY ON BEHALF OF THE NEW JERSEY CLIENT CLAIMED THAT WHEN THE CLIENT'S HUSBAND DIED IN NOVEMBER 2005, THE CLIENT WAS ADVISED TO ROLL OVER THE HUSBAND'S IRAS AND HIS ANNUITY AND/OR ANNUITIES INTO IRAS FOR THE CLIENT. THE CLIENT'S HUSBAND HELD A TRANSAMERICA IRA ANNUITY IN AN IRA ANNUITY ACCOUNT. ON JANUARY 10, 2006 THE TRANSAMERICA IRA ANNUITY THAT WAS HELD IN THE CLIENT'S HUSBAND'S IRA ANNUITY ACCOUNT WAS SURRENDERED AND A DEATH BENEFIT WAS TAKEN BY THE CLIENT IN THE AMOUNT OF \$91,836.01. THE FUNDS WERE THEN DEPOSITED INTO A NON-RETIREMENT ACCOUNT THAT HAD BEEN OPENED BY THE CLIENT THROUGH THE FA IN JANUARY 2006. THE ATTORNEY CLAIMED THAT THE CLIENT INSTRUCTED THE FA TO PLACE THE FUNDS IN AN IRA ACCOUNT, WHICH HE FAILED TO DO. THE DEATH BENEFIT RECEIVED BY THE CLIENT WAS REPORTED AS TAXABLE INCOME. THE ATTORNEY CLAIMED THAT IN JUNE 2008 THE CLIENT WAS ASSESSED TAXES, INTEREST AND PENALTIES BY THE IRS IN THE AMOUNT OF \$38,544 ON THE DEATH BENEFIT PAID OUT TO THE CLIENT. THE CLIENT SEEKS TO RECOVER THE MONIES PAID TO THE IRS.
