IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

In February 2019, I filed for Chapter 7 bankruptcy due to my personal guarantee on loans for my small business. This action became necessary after my company's largest customer filed for bankruptcy, leaving significant unpaid invoices. Consequently, the bank called in our line of credit and was unwilling to extend or restructure the terms of the loan.

Although the financial difficulties were strictly related to my business, I was required to personally file for Chapter 7 bankruptcy to discharge the personal guarantees. It is important to note that I have never defaulted on any personal financial obligations, before or after this event.
