Where did this information come from?

Broker Statement

At the time the investment was purchased (January 26, 2007), I advised the client not to buy the investment given the high risk involved with the security (a USD-denominated unsecured bond issued by Vitro S.A.B. de C.V., a Mexican industrial conglomerate) and the high concentration of the security in the client's investment portfolio. Contrary to what I told him, the client opted to proceed and purchase the investment at his own risk. This was documented in a call record at the time of purchase (January 2007) reflecting the conversation I had had with the client.

The complaint does not address the reason why it was filed almost nine-and-a-half years after the purchase date and almost seven-and-a-half years after the company was declared insolvent (February 2009). Furthermore, the insolvency of the investment occurred almost two years after I stopped covering this client and severed all communications with him. I cannot opine on, or attest to, any advice given to the client in the two years leading to the company's insolvency.
