Broker Statement

I WAS NOT A PARTY TO THE ISSUE REGARDING A TAX PAYMENT. I PURCHASED PPL ON AN UNSOLICITED BASIS AND SUBSEQUENTLY LEARNED FROM THE CLIENT THAT THE STOCK SYMBOL SHE PROVIDED WAS INCORRECT. WE SOLD PPL AND PURCHASED PPD AT HER REQUEST AND I FURTHER PURCHASED 1000 SHARES OF DENISON MINES (DNN) ON AN UNSOLICITED BASIS AT HER REQUEST. IN RESPONSE TO HER DISAPPOINTMENT WITH THE ENSUING VALUE OF THE STOCK, I SUGGESTED A SELL LIMIT ORDER ON THIS POSITION. SHE AGREED AND ON JANUARY 5, 2009, I EXECUTED A TRADE FOR 300 ADDITIONAL SHARES OF DENISON MINES CORP. AT HER REQUEST. I WAS NOT THE LEAD ADVISOR WITH REGARD TO DISCUSSIONS PERTAINING TO THE TERMINATION OF MANAGEMENT FEES AND THE CLIENT'S IRA WAS NEVER PLACED IN A FEE-BASED ACCOUNT ARRANGEMENT. STRUCTURED PRODUCTS WERE DISCUSSED IN 3 SEPARATE MEETINGS BEFORE PURCHASE AND PROSPECTUSES WERE PROVIDED. THEY WERE PRESENTED WITHIN THE CONTEXT OF REVIEWING A COMPREHENSIVE FINANCIAL PLAN IN WHICH WE DETERMINED AN APPROPRIATE ASSET ALLOCATION AND RISK TOLERANCE. I RECOMMENDED, AND THE CLIENT AGREED, TO PURCHASE BOTH PRINCIPAL PROTECTED AND PARTIALLY PROTECTED NOTES IN HER IRA, AS ANY POTENTIAL GAIN WOULD NOT BE A TAXABLE EVENT AT MATURITY AND BECAUSE OF THE ILLIQUID NATURE OF THE NOTES OVER AN 18-MONTH PERIOD.
