What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: IN MARCH 2010, A CLIENT PURCHASED FOUR DIFFERENT REAL ESTATE INVESTMENT TRUSTS (REITS) FOR A TOTAL OF \$80,000 WHILE MR. SCHUMACHER WAS REGISTERED WITH ANOTHER BROKER-DEALER, FIRST ALLIED SECURITIES, INC. THE CLIENT NOW RAISES SUITABILITY CONCERNS NOTWITHSTANDING HIS RECEIPT OF PROSPECTUSES AND OTHER DOCUMENTS AND DISCLOSURES AND FURTHER NOTWITHSTANDING THAT HE PROVIDED FINANCIAL INFORMATION SUPPORTING HIS SUITABILITY FOR THE INVESTMENTS. THE CLIENT'S CONCERNS APPEAR TO BE BASED ON ARTICLES AND BLOG ENTRIES THAT HE FOUND ON THE INTERNET FOR SIMILAR (BUT NOT THE SAME) SECURITIES. THE CLIENT WAS ADVISED IN WRITING ABOUT HIS SUITABILITY, DISCLOSURE AND THE NATURE OF THE SECURITIES IN QUESTION AND WAS DIRECTED TO THE DIFFERENT SECURITIES ISSUERS FOR ADDITIONAL INFORMATION ABOUT SHARE REDEMPTION PROGRAMS THAT MAY BE AVAILABLE. NO FURTHER ACTION WAS TAKEN.

Broker Statement

IN MARCH 2010, THE CLIENT RECEIVED AND SIGNED ALL THE APPROPRIATE DOCUMENTS, INCLUDING DISCLOSURES THAT CLEARLY STATED THAT SUCH REITS ARE ILLIQUID. RECENTLY, THE CLIENT FORWARDED EMAILS TO MR. SCHUMACHER WHICH CONTAINED INTERNET REIT-RELATED BLOGS AND ON-LINE REIT ARTICLES. HOWEVER, THESE FORWARDED INTERNET BLOGS/ARTICLES WERE REFERENCING NOT THE SAME REITS THAT THE CLIENT HAD PURCHASED, THUS LED THE CLIENT TO INCORRECTLY CONCLUDE THAT HIS REIT INVESTMENTS WERE NOT APPROPRIATE. AS A RESULT, MR. SCHUMACHER SENT THE CLIENT A DETAILED LETTER. IN HIS LETTER, HE REMINDED THE CLIENT THAT THESE INVESTMENTS WERE MEANT TO BE HELD LONG-TERM, AND THAT THE INVESTMENTS CONTINUED TO PAY DISTRIBUTIONS (IN ADDITION TO THE 2 YEARS OF DISTRIBUTIONS THE CLIENT HAD ALREADY RECEIVED). FURTHER, THE CLIENT WAS ADVISED TO SEEK PARTICIPATION IN THE RESPECTIVE SHARE REDEMPTION PROGRAMS RELATED TO THESE INVESTMENTS. THE REDEMPTION PROGRAMS FOR THE INVESTMENTS WERE OPEN AS OF THE TIME MR. SCHUMACHER RESPONDED TO THE CLIENT'S CONCERNS. MR. SCHUMACHER BELIEVES THAT THERE ARE NO DAMAGES.
