What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: NJ RESIDENT WRITES REGARDING EQUITABLE ACCUMULATOR PLUS ANNUITY PURCHASED FOR \$2MILLION ON 2/28/08. SHE STATES THAT SHE WAS NOT CORRECTLY INFORMED ABOUT THE GUARANTEED INCOME BENEFIT AND GUARANTEED DEATH BENEFIT AND STATES ALSO THAT IT ISN'T SUITABLE FOR A PERSON TO INVEST 80% OF ASSETS IN ONE PRODUCT.
