What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement I deny any allegation of wrong doing in placing the annuity order as the client suggests. The order was placed exactly how the client requested into their current subaccount allocations, which I believed to be the current subaccount the annuity was in. However, prior to my being their advisor and without my knowledge, the clients had a conversation with the annuity company almost 10 years ago, confirming that all new additions go into 5 different subaccounts. Thus, upon finding the misunderstanding the annuity company reversed the trade for the client. The clients claim that I invested their funds into accounts against their wishes is untrue. After completion of the firm's investigation, the client's claim was resolved in the amount of \$2,852.97 and by placing the annuity trade into the subaccount as agreed upon by the client.
