IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

In response to clients unfounded complaint dated 08/13/17. Client approached me looking for information on our Structured CD Offerings, because he was looking for a higher rate of return on his idle cash than the bank could offer. After a lengthy two hour meeting with the client and a deep profiling session, a recommendation was made to purchase a Structured CD. After explaining the terms completely, following all proper procedures, giving all required documentation and disclosures, the purchase was completed. At the time of purchase, it was mutually agreed upon by myself and the client, that this product was both completely understood, appropriate for the client's current needs, and fit within his risk tolerance and investment objective. Upon receiving a complaint from the client, HSBC did a thorough internal investigation. HSBC concluded that there was no merit to the complaint. I also believe that it is important to note, that during my 30 years in this industry, that this is the first customer complaint that I have needed to address.
