**Broker Statement**

After review, it did not appear that the failure to process the transfer out to E\*Trade timely was the result of advice, and/or action or inaction, by the representative, Ms. Zaya. Instead, it appears that the transfer was not diligently pursued by E\*Trade or the client within the window of liquidity.

However, while Ms. Zaya was not responsible for the failure of the client and E\*Trade to pursue the completion of the transfer out, Ms. Zaya, her branch manager, and the Firm wished to assist the client if we could. As such, Ms. Zaya and her branch manager contacted Security Benefit to request an accommodation, and clearly outlined the client's intentions and timeline. Fortunately, Security Benefit, after consideration, ultimately allowed a surrender free transfer and expedited the transfer to E-Trade. That transfer is now complete.
