**Broker Statement**

The claim has been denied. The firm concluded that Representative did not misrepresent the risks associated with his recommendation. After the customer had contacted him in September 2020 to discuss alternatives to bank CD's paying 0.50%, Representative recommended a portfolio of diversified mutual funds with an allocation of approximately 20% stocks and 80% bonds. He fully discussed the risks of these non-guaranteed investments, which the customer agreed to accept. The customer's account declined in value during the first half of 2022, as a result of market fluctuation caused by the Russian invasion of Ukraine, a rise in energy prices, interest rate hikes, and other economic factors. The total decline in value was approximately 10%.
