IAPD Information About Representatives

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Employing firm when activities occurred which led to the complaint: ANALYTIC FINANCIAL SOLUTIONS, INC.

Allegations: ON OR ABOUT AUGUST 5, 2004, A CLIENT'S ATTORNEY SENT ANALYTIC FINANCIAL SOLUTIONS A LETTER ACCUSING THEM OF FRAUD, NEGLIGENCE, AND BREACH OF FIDUCIARY DUTY, AMONG OTHER THINGS. KNOWING THEY HAD ACTED APPROPRIATELY, ANALYTIC FINANCIAL SOLUTIONS FILED A DECLARATORY JUDGMENT ACTION IN THE CIRCUIT COURT OF THE 15TH JUDICIAL CIRCUIT IN PALM BEACH COUNTY, FLORIDA ON AUGUST 11, 2004. ANALYTIC FINANCIAL SOLUTIONS SOUGHT A DETERMINATION THAT THEY DID NOT BREACH ANY OF THEIR DUTIES OR LEGAL OBLIGATIONS AND DID NOT BREACH THE TERMS OF THE PARTIES AGREEMENT. ANALYTIC FINANCIAL SOLUTIONS LATER AMENDED THE COMPLAINT ADDING A CLAIM FOR BREACH OF CONTRACT ARISING OUT OF THE CLIENT'S FAILURE TO PAY THE AGREED MANAGEMENT FEES".

THE CLIENT COUNTER SUED NAMING ANALYTIC FINANCIAL SOLUTIONS, GIBSON AND HIS BUSINESS PARTNER. THIS WHOLE PROCESS STARTED AS A CUSTOMER INITIATED COMPLAINT BUT NOT A CUSTOMER INITIATED LAWSUIT. ANALYTIC FINANCIAL SOLUTIONS WAS ACTUALLY THE ONE THAT INITIATED THE SUIT AGAINST THE CUSTOMER. WE STOPPED MANAGING HIS ACCOUNT IN APRIL 2004. THE LAWSUIT WAS FINALLY SETTLED BEFORE EVER GOING TO COURT ON MAY 22, 2006. WE AGREED TO PAY HIM \$57,500 OR \$28,750 EACH TO JUST GO AWAY.
