**Firm Statement** ACCORDING TO MR. BEZIGIAN, HE DOES NOT RECALL A REQUEST FROM THE CLIENT TO LIQUIDATE AND/OR EXCHANGE ALL THEIR AMERICAN



FUNDS MUTUAL FUNDS TO THE CASH MANAGEMENT TRUST IN JUNE OF 2008. OUR CONTACT NOTES REFLECT CLIENT HAD AN APPOINTMENT IN THE BRANCH OFFICE ON JUNE 10, 2008, AND IT APPEARS THERE WAS A DISCUSSION REGARDING THE CLIENT'S RMD FROM THE RETIREMENT ACCOUNT AND WHAT MUTUAL FUND WAS GOING TO BE SOLD TO MEET THE RMD. IT ALSO APPEARS DURING THIS MEETING, THERE WAS A DISCUSSION RELATING TO MAKING CHANGES WITH A PORTION OF THE MUTUAL FUND HOLDINGS IN EACH OF THE ABOVE-REFERENCED ACCOUNTS AND EXCHANGES WERE PROCESSED. (THIS ACTIVITY IS REFLECTED ON THEIR JUNE ACCOUNT STATEMENTS.) DURING MY DISCUSSION WITH MR. BEZIGIAN, HE INDICATED CLIENT DID NOT EXPRESS CONCERNS RELATED TO EXCHANGES NOT BEING COMPLETED (IN JUNE) DURING THE REMAINDER OF HIS EMPLOYMENT WITH EDWARD JONES. IN CLIENT'S LETTER THEY HAVE ALSO INDICATED THEY CONTACTED OUR FIRM IN SEPTEMBER TO SEE HOW THEIR ACCOUNTS WERE DOING. IF IN FACT THE CLIENT BELIEVED ALL THEIR MUTUAL FUNDS WERE MOVED TO CASH IN JUNE, I AM UNCERTAIN WHY THEY WOULD BE CHECKING ON THEIR INVESTMENTS IN SEPTEMBER. IN ADDITION, OUR CONTACT NOTES REFLECT THE CLIENT SPOKE WITH OUR OFFICES IN TRANSITION (OIT) REPRESENTATIVE ON SEPTEMBER 8, 2008 AND THEIR ACCOUNTS AND MARKET CONCERNS WERE DISCUSSED. WHILE I UNDERSTAND CLIENT'S DISAPPOINTMENT WITH THE PERFORMANCE OF THEIR ACCOUNTS BETWEEN JUNE AND SEPTEMBER, WE HAVE BEEN EXPERIENCING TURBULENT MARKET CONDITIONS AND MARKET FLUCTUATION IS A RISK ASSOCIATED WITH INVESTING. AS A RESULT OF MY REVIEW OF THIS SITUATION, WE RESPECTFULLY DENY CLIENT'S REQUEST FOR REIMBURSEMENT OF LOSSES ASSOCIATED WITH THE MUTUAL FUNDS HELD IN THE ABOVE-REFERENCED ACCOUNTS.
