IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	I AM WRITING TO EXPLICATE THE UNFORTUNATE CIRCUMSTANCES OF MY FALSE ARREST IN 1987. THE INTENTION OF THIS LETTER IS TO CLARIFY ANY QUESTION REGARDING THIS EVENT AND TO EXPEDITE THE PROCESSING OF MY EMPLOYMENT PAPERWORK. THIS EVENT STARTED ON JULY 16, 1987. WHAT TRANSPIRED BECAME ONE OF THE MOST PAINFUL MOMENTS IN MY LIFE AND WAS NOT A SIMPLE ERROR AT ALL. I WAS BEING CHARGED WITH ARMED ROBBERY. THE JUDGE ULTIMATELY DISMISSED THE CASE AT THE PRELIMINARY



HEARING DUE TO INSUFFICIENT EVIDENCE. FOR THE RECORD, I WAS NOT FOUND GUILTY AND THE CASE NEVER WENT TO TRIAL. THIS WAS AN EXTREMELY DIFFICULT TIME FOR ME AS I FELT MY CAREER AND LIFE WERE ABOUT TO BE TAKEN AWAY FROM ME AND THERE WAS NOTHING I COULD DO ABOUT IT.
