What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: CLIENT SUBMITTED A WRITTEN COMPLAINT TO HANTZ FINANCIAL SERVICES, INC. DATED OCTOBER 7, 2011 AND RECEIVED OCTOBER 12, 2011. CLIENT COMPLAINED THAT JERALD HANKS FAILED TO COMMUNICATE AND MADE IMPROPER RECOMMENDATIONS. UPON REVIEWING THE FILE AND OBTAINING WRITTEN RESPONSE FROM JERALD HANKS, THE PRESIDENT AND THE CHIEF COMPLIANCE OFFICER SPOKE WITH JERALD HANKS AND CONTACTED [CUSTOMER] ASKING TO MEET TO GO OVER THE FINDINGS. [THIRD PARTY], PRESIDENT OF HANTZ FINANCIAL SERVICES, INC., SET MEETINGS WITH [CUSTOMER] FOR DECEMBER 23 WHICH [CUSTOMER] HAD TO CANCEL, AND ON JANUARY 6 WHICH [CUSTOMER] DID NOT SHOW UP AND THEN MET WITH [CUSTOMER] ON JANUARY 13, 2012 TO REVIEW THE COMPLAINTS AND SHOWED [CUSTOMER] THAT THE LOSS IN THE ACCOUNTS AMOUNTED TO \$8127.00. FURTHER, ALL PAPERWORK REQUIRED TO CONDUCT ALL BUSINESS WAS SIGNED BY [CUSTOMER] AND A SIGNED STATEMENT FROM [CUSTOMER] ACKNOWLEDGING THAT FOR THE JULY 2009 TRANSACTION WAS HER CHOICE FROM FOUR ALTERNATIVE STRATEGIES THAT JERALD HANKS OUTLINED FOR HER GIVEN THEIR CURRENT FINANCIAL SITUATION AND THE ECONOMY. [CUSTOMER] CHOSE ONE OF THE FOUR STRATEGIES IN WRITING WITH THE UNDERSTANDING THAT SHE WOULD BE GIVING UP SOME BENEFITS AND THAT SHE WILL INCUR SURRENDER CHARGES.
