IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Employing firm when activities occurred which led to the complaint: EDWARD JONES

Allegations: THE CLIENT ADVISED THAT WHEN HER ASSETS WERE TRANSFERRED INTO EDWARD JONES THE FA RECOMMENDED THAT SHE SELL ALL OF HER STOCKS AND MUTUAL FUNDS AND REINVEST THE PROCEEDS BASED ON HIS RECOMMENDATIONS. THE VALUE OF THE ACCOUNT WAS APPROXIMATELY \$420,000.00. AT THE TIME, THE CLIENT ALLEGED THAT SHE WAS TOLD THAT THIS WOULD BE BETTER FOR HER SINCE THE ACCOUNT WOULD PAY HER \$1,000.00 PER MONTH. SHE FELT THAT THIS WAS A MUCH BETTER INCOME STREAM THAN THE SMALL AMOUNT OF DIVIDENDS THAT SHE WAS PREVIOUSLY RECEIVING ON HER INVETSMENTS. SHE WAS ADVISED THAT THERE WOULD BE SOME TAXES DUE BECAUSE OF THE STOCK SALES, BUT THAT EDWARD JONES WOULD SEE THAT THE TAXES WERE PAID AND THAT THIS INFORMATION WOULD BE MAILED TO HER ACCOUNTANT. THE ACCOUNTANT NEVER RECEIVED ANYTHING FROM EDWARD JONES PERTAINING TO THESE SALES AND HAS NOW ADVISED THE CLIENT THAT SHE OWES \$84,535.00 IN TAXES DUE BY APRIL 16, 2007.

THE FA SUGGESTED REPOSITIONING THE CLIENT'S STOCK PORTFOLIO INTO INCOME PRODUCING INVESTMENTS. THE FA FOLLOWED THE FIRM'S GUIDELINES FOR SETTING UP THIS PORTFOLIO FOR A CLIENT WHO IS 86 YEARS OLD. THE CLIENT INCREASED HER INCOME WITH SAFER AND LESS VOLATILE INVESTMENTS AND WAS ALSO ABLE TO PURCHASE SOME OF THE THINGS THAT SHE DESIRED. THE FA SUGGESTED THAT \$80,000.00 BE PLACED IN SHORT TERM CD'S MATURING IN JANUARY 2007 TO HELP PAY THE CAPITAL GAINS TAX ON THE SALE OF HER STOCKS. THE CLIENT HAD NO BENEFICIARIES OR HEIRS WHO WOULD BENEFIT FROM THE STEPPED UP COST BASIS ON THE STOCKS. THE CLIENT AUTHORIZED ALL TRANSACTIONS AND WAS AWARE OF THE TAX LIABILITY AND ALL FEES AND COMMISSIONS ASSOCIATED WITH THESE TRADES. THE CLIENT'S REQUEST TO UNDO THESE TRADES AND REPOSITION THEM BACK INTO HER STOCKS WAS DENIED.
