Broker Statement CLIENT CAME IN SEARCH OF ALTERNATIVES TO CERTIFICATES OF



DEPOSIT, BECAUSE HER REINVESTMENT RATE WAS GOING TO DROP SIGNIFICANTLY UPON RENEWAL OF EXISTING CD'S, AND SHE WAS CONCERNED ABOUT A BIG REDUCTION IN INCOME. I PROPOSED A SHORT DURATION, MULTI ASSET CLASS, FIXED INCOME MUTUAL FUND PORTFOLIO BECAUSE OF HER CONSERVATIVE PROFILE, AND EXPLAINED THE POTENTIAL VOLATILITY OF THIS PORTFOLIO AND SHOWED HER A 13 ½ YEAR TRACK RECORD OF THE EXACT PROPOSED PORTFOLIO VIA MORNINGSTAR SERVICE, SO SHE COULD BETTER UNDERSTAND THE POTENTIAL VOLATILITY, AND THE LEVEL OF INCOME SHE SHOULD EXPECT ON A MONTHLY BASIS. I ALSO EXPLAINED THAT SHE MUST COMMIT TO HOLDING THIS PORTFOLIO FOR AT LEAST A FEW YEARS IN THE EVENT OF INTEREST RATE CHANGES AND BOND MARKET VOLATILITY. SHE INVESTED IN APRIL 2013. THE BOND MARKET IN GENERAL EXPERIENCED A PRETTY SIGNIFICANT PRICE DROP BEGINNING IN JUNE 2013 DUE TO FEDERAL RESERVE COMMENTS REGARDING THE REDUCTION OF THE FED'S QUANTITATIVE EASING POLICY, AND THIS CLIENT'S PORTFOLIO EXPERIENCED A PRICE DROP ALSO, BUT, BECAUSE OF THE SHORT DURATION, THE PRICE DROP WAS MINIMAL RELATIVE TO THE OVERALL BOND MARKET. THE CLIENT WAS INVESTED APPROXIMATELY 4 MONTHS IN AUGUST 2013 WHEN SHE INSISTED I SELL THE PORTFOLIO. THE CLIENT ULTIMATELY REALIZED A LOSS OF LESS THAN \$4,000 OR APPROXIMATELY 5.4%, BUT SHE MISTAKENLY CLAIMS MORE THAN \$5,000. THE TIMING OF THE LIQUIDATION WAS POTENTIALLY AS BAD AS POSSIBLE, BECAUSE THE BOND MARKET BEGAN A REVERSAL BACK TO THE UPSIDE THE VERY NEXT DAY, AND NOW, IN OCTOBER 2013, IS WELL ABOVE THE LEVEL IT WAS ON LIQUIDATION DAY.
